Sub: Improvement, operation and maintenance including strengthening and widening of existing 2-lane road to 4-lane dual carriageway from Km.9.200 to Km.50.000 of NH-6 (Nagpur- Kondhali section) in the State of Maharashtra on Build, Operate and Transfer (BOT) basis- **Proposal for laying of OFC cable through HDD Method, Open Trenching, Clamping and other suitable method from km 9.200 to km 12.800 on RHS on NH-53 by. M/s Voda Idea Telecom Infrastructure Ltd. - Reg.**

It is to inform all concern that M/s Vodafone Idea Telecom Infrastructure vide letter under reference (ii) has submitted a proposal for the subjected work and PD, NHAI, PIU, Amravati has recommended the above proposal vide letter under reference (i) for approval of the Competent Authority / Highway Administrator.

2. The alignment proposed by M/s Vodafone Idea Telecom Infrastructure is from 9.200 (Wadi) to km 12.800 (Ambazari) on RHS on NH-53 in the State of Maharashtra. The following activity is involved:

- Underground Optical Fiber Cable to be laid in duct in utility corridor from km. 9.200 (Wadi) to km 12.800 (Ambazari) on RHS section of Nagpur - Kondhali of NH-53 at the edge of RoW.

3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).

4. In view of the above, the comments / objections of affected public is hereby invited with reference to the Ministry's circular dated 22.11.2016 due to above underground line on the subjected stretch.
