- SUB: Short Term Improvements & Routine maintenance of Surat Dahisar Section from Km. 263.000 to Km. 381.000 on NH-48 in the state of Gujarat.
 - Proposal seeking ROW permission for Laying for 66KV IC, 630 sqmm 2x(3+1)
 XLPE Power Cable from 220KV Vapi Sub-Station to feed power supply to new proposed 66kv Vatar Sub-station 1 no. of Crossing at Km 362+135 (between Km 362+000 to Km 363+000) and Parallel laying from Km 362+500 to Km 362+135 of NH-48 on LHS, Village-Balitha, Taluka-Vapi, Dist-Valsad in the state of Gujarat.

Gujarat Energy Transmission Company Limited-Navsari vide their office letter u/ref.(2), in compliance to the then PD, PIU-Bharuch office letter u/ref.(3), <u>seeking ROW permission for Laying for 66KV IC, 630 sqmm 2x(3+1) XLPE Power Cable from</u> <u>220KV Vapi Sub-Station to feed power supply to new proposed 66kv Vatar Sub-station 1 no.</u> of Crossing at Km 362+135 (between Km 362+000 to Km 363+000) and Parallel laying from Km 362+500 to Km 362+135 of NH-48 on LHS, Village-Balitha, Taluka-Vapi, Dist-Valsad in the state of Gujarat.
