INVITATION OF PUBLIC COMMENTS

Sub:- NHAI-RO Kerala- Six laning of Kodungallur-Edapally from Km.397+850 to Km.423+000 of NH-66 (Old NH-17) in the State of Kerala under Bharatmala Pariyojana-Crossing of Water Pipeline (32mm Dia) at Km.419+630 of NH-17(New NH-66)-Reg.

The proposal is regarding permission sought by Amrita Vishwa Vidyapeetham, Kochi for crossing of 32mm pipeline at Km.419+630 of NH-17(New NH-66) along the subject project stretch in the State of Kerala.

- 2. Amrita Vishwa Vidyapeetham, Kochi has furnished undertaking to shift the UG cable at their own cost at an alternate location whenever NHAI make a request for shifting of the same. Further, the applicant has undertaken for confirming with all standards as mentioned in the Ministry's Circular.
- 3. Further, Amrita Vishwa Vidyapeetham, Kochi has undertaken that they will not damage any other utility during the process on laying and in case, if damaged, then to pay the losses either to NHAI or to the agency concerned. Further, Amrita Vishwa Vidyapeetham, Kochi has undertaken to bear the expenditure incurred by NHAI for repairing any damages caused to the NH by laying, maintenance or shifting of the proposed water supply line.
- 4. As per the guidelines issued by the Ministry vide letter No.RW/NH33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by Amrita Vishwa Vidyapeetham, Kochi will be made available for 30 days seeking public Comments/objections and the comments shall be furnished within 30 days from the day of closure of public objections.
