This is to mention that the applicant i.e. DW&SD, Dumka had sent the proposal regarding laying of water pipeline in the area of Saraiyahat and Ramgarh under Bahugramin Jalpurti Yojna vide letter u/r (1), thereafter Proposal was forwarded to Independent Engineer vide letter u/r (2) to examine the proposal in accordance MoRTH guidelines i.e. RW/NH-33044/29/2015/S&R(R) dt. 22nd November, 2016.

Accordingly, Independent Engineer had submitted the report vide letter u/r (3), as per IE report chainage/location and length of water pipeline in the subject project was totally differ from chainage/location and length mentioned in the applicant proposal. Thereafter, on the basis of Independent Engineer report the proposal was returned.


Again, proposal was re-submitted by applicant i.e. DW&SD, Dumka vide letter u/r (4), subsequently proposal was forwarded to Independent Engineer vide letter u/r (5), after verification of proposal Independent Engineer had submit the report vide letter w/r (6), in which the water pipeline which is actually crossing the existing stretch of NH-133 in Poriyahat that chainage/location was not consider in Independent Engineer Report, for which clarification was sought by this office to Independent Engineer to revise the chainage/location and to submit complete bifurcation chainage wise details of total water pipeline in existing/bypass portion. After rectification IE had submitted the report vide letter u/r (8). Subsequently proposal had return to applicant vide letter u/r (9) to revise the proposal in accordance to Independent Engineer Report.

After rectification, proposal has submitted by applicant i.e. DW&SD, Dumka vide letter u/r (10), there after proposal was forwarded to IE vide letter (11), to examine the proposal and submit the comments to issues the NOC by authority.

Accordingly, Independent Engineer has submitted the Report vide letter u/r (12) and submitted its comments that proposal has examine and is found in order. under this situation, NOC may be accorded by authority for the cited subject and issued to concerned executing department based on the to the conditions set forth in MoRTH Circular RW/NH-33044/29/2015/S&R(R) dt 22nd November.2016.

In this regard, the proposal is being submitted with a recommendation for your kind perusal and approval please.
