### Invitation of Public Comments

**Sub:** NOC for laying of 4 inch DIA pipe below the bridge over the Khanpur Nallah at Nagrota Reg.

The proposal is regarding laying of 4 inch DIA pipe below the bridge over the Khanpur Nallah at Nagrota for Jambu Zoo has been submitted to this office by PD PIU Jammu letter No. 11022/1/2017/PIU-JMU/J-U/951 dt 02.05.2022 in accordance with Ministry guidelines dated 22.11.2016.

2. Additional Wildlife Warden, Jambu Zoo, Jammu intends to lay 4 inch DIA pipe below the bridge over the Khanpur Nallah at Nagrota for Jambu Zoo at Km 09+800 Nagrota Bypass.

3. The submitted proposal is in conformity with Ministry's latest guidelines dated 22.11.2016 regarding accommodation of public and industrial utility services along and across National Highways.

4. Additional Wildlife Warden, Jambu Zoo, Jammu has furnished an Undertaking to the effect that they will shift the pipeline if required at any time owing to expansion of the road or if necessary by the NH Authority at his own cost and risk without claiming any cost from NHAI. Further, they have furnished an undertaking that not to damage other utility, if damaged then to pay the losses either to NHAI or to the concerned agency. The applicant has undertaken to indemnify against all damages and claims by NHAI. Also, certified that the proposed laying of pipeline will not have any deleterious effect on any of the bridge components and road way safety for traffic.

5. As per the guidelines issued by the Ministry vide letter No. RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by Additional Wildlife Warden, Jambu Zoo, Jammu will be made available for public comments/objections and the comments will be invited within 30 days from the date of uploading.
