Sub: NHAI - PIU, Salem - Proposal of laying the water pipe by open excavation along the NH-68 from Km 0/575 to Km 03/920 - 3345m (RHS) and across the road by HDD Method at Km 01/725 - 73m & Km 03/540 - 73m by the Executive Engineer, TWAD Board, RWS Division, Salem - Approval requested - Reg

- 1). The subject proposal is requesting permission for laying of water pipe line along the NH-68 by open excavation of 300mm Dia pipe from Km 0/575 to Km 1/725, 250mm Dia pipe from Km 1/725 to Km 2/470, 200mm Dia pipe from Km 2/470 to Km 3/540 & 150mm Dia pipe from Km 3/540 to Km 3/920 and 323.9 mm dia MS casing with 150mm dia water line by HDD Method across NH at Km 01/725 - 73m & Km 03/540 - 73m in the project of Salem - Ulundurpet section of NH-68 in the State of Tamil Nadu.
- 2). The TWAD Board, Salem has furnished an undertaking to move the utility line for any work of improvement or repairs to the road, if NHAI considers if necessary in future, it will be carried out as desired by the NHAI at their cost within a reasonable time (not exceeding 90 days) of the intimation given. Further, the applicant has furnished the undertaking for payment of rent / fee as mentioned in the Ministry's Circular No.RW/NH-33044/29/2015-S&R dated 22.11.2016 as when asked by NHAI.
- 3). As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by M/s TWAD Board, Salem will be made available for 30 days seeking public
