



The point wise reply of the observations are as follows: -

- 1. Incorporation in the drawing (Attached):
 - a) The diameter of the pier has been mentioned as 2 meter.
 - b) Center to center distance between the pier is 15 meter at both side of the SH.
 - c) The distance from pier face to the center of existing SH road is 13.5 m for the first pier and 14.5 meter for he second pier. It is worth mentioning that the laying of proposed pipeline is not in the side of road from the pier face, but to the opposite side.
 - d) The RoW of the existing SH road is 52 ft.
 - e) The distance of the proposed line earlier taken as 7 meter has been modified to 7.5 meter as required.
 - f) The construction of drain has already been incorporated in the drawing and minimum depth of cover over the casing pipe has been taken as 2 meters.
 - g) The alignment of the proposed pipeline has already been marked in the drawing in red colour and mentioned in drawing as PR. Pipeline.
- 2. The width of RoW of the Ring road has been corrected as 60 meter in the drawing as well as in the calculation sheet for the license fee calculation (Attached).
