## **INVITATION OF PUBLICE COMMENTS**

Sub: NHAI - PIU, Trichy - Padalur - Trichy section of NH 38 - Permission for laying of water supply pipeline across NH at km.306/715 - Across NH road for SRV Matriculation Higher Secondary School at Samayapuram in the State of TamilNadu - Invitation of Public Comments - Reg.

The proposal received from PD, Trichy vide letter No. NHAI/PD/TRY/Utility/NH-38/VI C/Pipeline/2022/ 2369 dated 02.12.2022 there by requesting permission for water pipe line laying across NH at Km 306/715 in Padalur - Trichy section of NH 38in the State of TamilNadu proposed by, Joint Secretary, M/s. SRV Matriculation Higher Sec. School, Samayapuram. in accordance with Ministry's latest guidelines dated 22.11.2016.

2) The alignment proposed by the, Joint Secretary, M/s. SRV Matriculation Higher Sec. School, Samayapuram. requesting permission for laying of water pipe line across NH at Km 306/175 in Melur to Karaikudi Section of NH-338,383 & 38 in the State of TamilNadu detailed as under;

- 3) Joint Secretary, M/s. SRV Matriculation Higher Sec. School, Samayapuram has mentioned that the Water supply pipeline by HDD method at a depth of 2.50m below the top of the Sub grade which satisfies the Ministry stipulation of minimum 1.20m.
- 4) Joint Secretary, M/s. SRV Matriculation Higher Sec. School, Samayapuram, has furnished an undertaking to the effect that the applicant will remove the laid Water supply pipeline in future if required by NHAI/MoRTH, Govt. of India at any time for expansion of the NH at their own cost without claiming any compensation. Further,

mentioned that Joint Secretary, M/s. SRV Matriculation Higher Sec. School. Samayapuram will also restore the surfaces to its original condition soon after removal of the Water supply pipelines.

5) Accordingly, as per Policy Guidelines issued by Ministry vide letter No. RW/NH-33044/29/2015/S&R(R) dated 22.11.2016., the application is being uploaded on public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
