INVITATION OF PUBLIC COMMENTS

Sub:- NHAI-RO Kerala- Four Lane Walayar - Vadakkanchery (Km 182.250 to Km.240.000) of NH-544 on BOT (Toll) basis - Operation & Maintenance stage in the state of Kerala -Request for laying of OFC cable and installation of Manhole (MH) along NH-544 from Km.203+045 to Km.208+100 (LHS), Km.209+030 to Km.210+800 (LHS), Km.210+900 to Km.215+744 (LHS), Km.208+200 to Km.208+900 (RHS), 209+000 to 213.100 and crossings of NH-544 at Km.203+010, Km.207+720, Km.208.100, Km.210+800, Km.210+900 by M/s Jio Digital Fibre Limited-Approval-Reg

The proposal is regarding permission for laying of OFC cable from Km.203+045 to Km.208+100 (LHS), Km.209+030 to Km.210+800 (LHS), Km.210+900 to Km.215+744 (LHS), Km.208+200 to Km.208+900 (RHS), 209+000 to 213.100 and crossings of NH-544 at Km.203+010, Km.207+720, Km.208.100, Km.210+800, Km.210+900 in the NH-544 by M/s Jio Digital Fibre Limited in the State of Kerala.

2. M/s Jio Digital Fibre Limited has furnished an undertaking to shift the utility service as and when required by NHAI at the cost of the applicant at their own cost at an alternate location whenever NHAI make a request for shifting of the same. Further, the applicant has undertaken to confirm with all standard conditions in the Ministry's Circular No. RW/NH33044/29/2015-S&R dated 22.11.2016.

3. Further, M/s Jio Digital Fibre Limited has undertaken that they will not damage any other utilities during the process on laying and in case, if damaged, then to pay the losses either to NHAI or to the agency concerned. Further, M/s Jio Digital Fibre Limited has also undertaken to ensure management of traffic movement during laying of utility line. 4. M/s Jio Digital Fibre Limited has also undertaken to ensure that necessary safety clearances are obtained from authorities before applying to Highway administration and to bear expenditure incurred by NHAI for repairing any damages caused to the NH by the laying, maintenance or shifting of utility line.

4. As per the guidelines issued by the Ministry vide letter No.RW/NH33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by M/s Jio Digital Fibre Limited will be made available for 30 days seeking public Comments/objections and the comments shall be furnished within 30 days from the day of closure of public objections.
