Nagpur(Rural), Distr. Nagpur in Arut 2.0 Scheme- Reg.

It is to inform all concern that M/s Municipal Council Butibori vide letter under reference (ii) has submitted a proposal for the subjected work and PD, has recommended the above proposal vide letter under reference (i) for approval of the Competent Authority / Highway Administrator.

2. The alignment proposed by that M/s Municipal Council Butibori along on Madhya Pradesh/Maharashtra Border Nagpur Section of NH-7 in the State of Maharashtra is as follows:

- lowering & laying of 600mm GI Water Supply pipeline highway track on Wardha Nagpur Road from Umred Bypass Junction, Tah. Nagpur(Rural), Distr. Nagpur in Arut 2.0 Scheme.

3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
