Sub: NHAI-PIU-NSK-Widening of existing 2 lane carriageway to 4/6 lane divided carriageway configuration for Vadape-Gonde (Km 539.5 - Km 440) section of NH-3 in the State of Maharashtra - Proposal from M/s Bharti Airtel Ltd.'s for Laying Underground Optical Fiber Cable (OFC) from Km. 513.390 to Km. 514.590 (RHS), Km. 514.540 to Km. 514.590 (LHS), Km. 514.590 to Km. 515.360 (RHS) (Total Length 2.020 Km) & 1 Crossing at Km. 514.590 on NH-3 in the State of Maharashtra.

M/s Bharti Airtel Ltd. vide letter cited above has submitted proposal for Laying/Crossing Underground Optical Fiber Cable along/across ROW of NH-3 (Vadape-Gonde Section) of NH-3 for approval of the Competent Authority, Highway Administration.

From the submitted proposal, it is observed that, the laying Optical Fiber Cable is proposed along ROW of NH 3 (Vadape-Gonde Section) from Km. 513.390 to Km. 514.590 (RHS), Km. 514.540 to Km. 514.590 (LHS), Km. 514.590 to Km. 515.360 (RHS) (Total Length 2.020 Km) & 1 Crossing at Km. 514.590 on NH-3 in the State of Maharashtra.
- 3. As per Para-4 of Ministry Circular No. RW/NH-33044/29/2015/S&R(R), Dtd. 22.11.2016, the Highway Administration shall put out in the Public Domain for 30 days for seeking claims and objections (On grounds of Public inconvenience, safety and general public interest).
