EE, MSEDCL, Rural Div. Nashik vide letter cited above has submitted Proposal for Erection of 11 KV Electrical Overhead distribution Line along with (Sinnar-Shirdi Section) NH-160 for approval of the Competent Authority, Highway Administration.
