It is to inform all concern that M/s Maui Petroleum & Services vide letter under reference (ii) has submitted a proposal for the subjected work and PD, NHAI, PIU, Jalgaon has recommended the above proposal vide letter under reference (i) for approval of the Competent Authority / Highway Administrator.

2. The alignment proposed by that M/s Maui Petroleum & Services crossing Chikhali to Tarsod Section of NH-53 in the State of Maharashtra as follows:

- Erection & commissioning of 11KV XLPE underground cable crossing at km. 411.315 for petrol pump.
- Alignment of the cable is crossing Chikhali to Tarsod Section of NH-53
- Cable to be laid by Push through method.

3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
