

It is to inform all concern that M/s Orient Cement Ltd vide letter under reference (ii) has submitted a proposal for the subjected work and PD, NHAI, PIU, Jalgaon has recommended the above proposal vide letter under reference (i) for approval of the Competent Authority / Highway Administrator.

- 2. The alignment proposed by M/s Oreint Cement Ltd along on Chikhali Tarsod section of NH- 53 in the State of Maharashtrais as follows:
  - Underground Water Supply Pipeline for M/s Orient Cement Ltd on Crossing National Highway NH-53 (Old NH-6) at Km. 415.492 & along (Parallel) NH-53 from km. 415.400 to km. 415.492 for Water supply connection from MIDC Jalgaon main water line.
  - Alignment of the cable is along Chikhali- Tarsod Section of NH-6
  - Cable to be laid by Push Through method.
- 3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
