- 1). The subject proposal is requesting permission for laying of underground Optical Fiber Cable (OFC) along the NH-7 by open excavation of 40mm Dia PLB pipe from Km 228/062 to Km 228/600 - 0.538m (RHS), Km 228/062 to km 240/415 - 12.353m (LHS), Km 240/200 to Km 248/395 - 8.195m (RHS) and 150 mm dia RCC casing pipe by HDD Method across NH at Km 228/600 - 60m, Km 240/200 - 60m & Km 248/395- 60m in the project of Thumbipadi - Namakkal section of NH-7 in the State of Tamil Nadu.
- 2). M/s Telesonic Networks Limited, Chennai has furnished an undertaking to move the utility line for any work of improvement or repairs to the road, if NHAI considers if necessary in future, it will be carried out as desired by the NHAI at their cost within a reasonable time (not exceeding 90 days) of the intimation given. Further, the applicant has furnished the undertaking for payment of rent / fee as mentioned in the Ministry's Circular No.RW/NH-33044/29/2015-S&R dated 22.11.2016 as when asked by NHAI.
