**Invitation of Public Comments**

Sub:- Issue of Access permission for construction an approach road to the proposed new Petrol / Diesel retail outlet in Re-Survey No.578/14/2, 562/9, 562/42-3, 562/42-2 of Kilikollor Village, Kollam Taluk, Kollam District at Km 9/00(RHS) on NH-66 (Kollam Bypass) of Kerala State by M/s Essar Oil Limited – reg.

This office vide letter dated 25.09.2017 has accorded provisional NOC for construction of access to the above mentioned retail outlet with a condition to complete the construction as per approved drawings and furnish the completion certificate from the field authority within one year from the date of issue of provisional NOC. As such the proposal for issue of final permission and signing of license deed should have been submitted by 24.09.2018.

2. Now, the applicant M/s. Nayara Energy Limited (Formerly M/s Essar Oil Limited) vide letter dated 16.01.2020 addressed to this office has sought extension of time for constructing the access to the above mentioned retail outlet up to 31.12.2020 citing the reason that delay in obtaining Various approvals for the execution of proposed fuel station and scarcity of materials and labour for construction.



Since, the extension of time sought is more than 1 years from the issue of provisional NOC, the proposal comes under relaxation category with regard to the non-compliance of time frame for the construction of access to the above retail outlet. As per the guidelines, issued by the Ministry vide O.M. No.RW/NH-33023/19/99-DO-III dated 16.03.2016, the Highway Administration will make available the relaxation application for public comments, and the comments will be invited within 60 days from the day of uploading in the format enclosed as Form 'A'.


