Vide letter 1<sup>st</sup> cited, M/s AGP City Gas Private Ltd, Mysuru submitted the proposal as per MORT&H guidelines for issue of Permission to lay underground 125mm dia. MDPE Gas Pipeline & Valve Chamber from Km 197+474 to Km 198+085 on LHS for the total length 0.611Km along NH-766 of Kerala Border to Kollegala Section in the state of Karnataka.
