Invitation of public comments


Sub: Proposal for grant of access permission to a new fuel station of M/s BPCL abutting CH. 959/095 to 959/140 of NH-27 on RHS in survey/araji no .2466/2360,2467/2361 & 2365/2350 at Village Katunda, tehsil-begun, distt-Chittorgarh in state of Rajasthan.

M/s BPCL Oil Lid ie. The applicant vide letter no. UDP/NHAI/NRO Katunda dated 29.03.2019 has submitted a proposal to this office on above mentioned subject. The applicant has sought relaxation from Ministry Guidelines issued vide letter No. RW/ NH-33023/19/99-DO.III dated 24.07.2013 as the constriction started as per the approved plan in which the deceleration lane of 70m and acceleration lane of 100m was approved. The DL was constructed as per plan, while during the construction of AL, there was objection raised by villagers, because there is a culvert at structure no.960/1 at distance of 60m from the edge of boundary of fuel station. If AL is extended up to 100m, widening of culvert is required, which obstruct the approach to the lane of villagers and also create drainage problem. So keeping in mind the demands of the villagers, the AL was constructed for 50m against minimum stipulated distance of 100m as per Ministry's Guidelines, thus violating the Ministry Guidelines.

2.0 As per Ministry vide OM No. RW/ NH/33023/19/99-DO III dated 16.03.2016, the Highway Administrator will make available the relaxation proposal of Oil company for public comments, and the comments will be invited within 60 days from the day of uploading.

3.0 In view of the above the comments from public on above mentioned proposal is invited on public portal for access permission to fuel station on website of Ministry and Road Transport and Highways (www.morth.nic.in)

4.0 This is issued with the approval of Highway Administration-cum Regional Officer, MoRTH, Jaipur.
