Sub: Improvement, Operation and Maintenance including strengthening and widening of existing 2- lane road to 4 - lane dual carriageway from Km.09.200 to Km. 50.000 of NH-6 (Nagpur-Kondhali Section) in the State of Maharashtra on BOT basis - Proposal for laying of 11 KV underground electrical cable crossing from (i) km 26.750 near Dhamna village (ii) km 30.100 near Satnavari Village (iii) km 24.100 near Peth (iv) km 34.600 Fun & Food Village & (v) km 54.600 Patel Swanill Masod crossing in Nagpur Kondhali section of NH-6-Reg.

It is to inform all concern that M/s MSEDCL letter under reference (2) has submitted a proposal for the subjected work and PD, PIU, Amravati has recommended the above proposal vide letter under reference (1) for approval of the Competent Authority / Highway Administrator.

2. The alignment proposed by that M/s MSEDCL is Nagpur - Kondhali Section of NH-53 (old NH-6) in the State of Maharashtra is as follows:

- Crossing at km 26.750, km 30.100, km 24.100, km 34.600, km 54.600.

3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
