M/s Mahindra & Mahindra Ltd., Igatpuri vide letter cited above has submitted Proposal for Laying Overhead 33 KV Electrical Line on RSJ Poles along with (Vadape-Gonde Section) of NH-3 for approval of the Competent Authority, Highway Administration.

- 2. From the submitted proposal, it is observed that, the Laying Overhead Electrical Line is proposed along with (Vadape-Gonde Section) from 460.00 to 464.00 (Total Length 4.00 km) on NH-3.
