**Sub:** NHAI-PIU-NSK- 4-laning of Sinnar - Shirdi Section of NH 160 from Design Ch: 0/000 to 50/943 including Sinnar Bypass of 3.375 km in the State of Maharashtra on Hybrid Annuity Mode - Zilla Parishad, Nashik's Proposal for Crossing of Water Supply Pipeline under Jal Jeevan Mission at Pathare Khurd between Km. 35.800 to Km. 36.200 across NH-160.

Executive Engineer, Rural Water Supply Div., Zilla Parishad, Nashik vide letter cited above has submitted proposal for Laying / Crossing Water Supply Pipeline along / across NH-160 for approval of the Competent Authority, Highway Administration.

2. From the submitted proposal, it is observed that, the Crossing of Water Supply Pipeline under Jal Jeevan Mission across NH-160 (Sinnar-Shirdi Section) is proposed between Km. 35.800 to Km. 36.200 at Village Pathare Khurd, Tal. Sinnar, Dist. Nashik.

3. As per Para-4 of Ministry Circular No. RW/NH-33044/29/2015/S&R(R), Dtd. 22.11.2016, the Highway Administration shall put out in the Public Domain for 30 days for seeking claims and objections (On grounds of Public inconvenience, safety and general public interest).
