The Proposal is regarding permission for **Shifting and relocating of existing 6 Nos of EHT Towers**

(b). For a Total 6 Nos of EHT Towers **Shifting and relocating** on Madurai Aruppukottai Tuticorin road of NH-45B in the state of Tamilnadu by M/s. the Superintending Engineer, TNEB, General Construction Circle, Madurai

Also certified that, that proposed Shifting and relocating of existing 6 Nos of EHT Towers work will not affect the design stability, traffic safety and future improvement of the proposed stretch.
