It is to inform that M/s. Jio Digital Fibre Private Limited, vide letter no. JDFPL/OFC/ROW/ INTRACITY/ENTERPRISES/AP/TADEPALLI/NHAI/-16/8153 dated 30.11.2021 requested permission for laying Optical Fiber Cable(OFC) along the road on LHS from Km. 428/100 to Km. 430/100 for a length of 2000mts on Chilakaluripet - Vijayawada section of NH-16 near DGP office & Mangalagiri Mandal, Guntur District, Andhra Pradesh.

In this connection, PIU vide letter no. NHAI/PIU-Amaravati/11013/13(OFC)/2020/Vol.1/1719 dated 03.12.2021 forwarded the proposal to IE, M/s MSV Intl. Inc. in association with M/s Sri Infotech, with a request to examine the proposal as per MoRTH guidelines and to furnish necessary comments/ recommendations for taking further action.

Accordingly, IE, MSV Intl. Inc. in association with M/s Sri Infotech vide letter no. MSV_Sri Infotech/103/KAZA/2021/NHAI/0273 dated 28.12.2021 communicated following observations:

- 1. Applicant has not shown structures details in submitted Strip plan/Route plan.
- Applicant has not submitted the drawing of HDD Bore Section of proposed OFC Cable.
- 3. Name of the project was mentioned as "Vijayawada Chennai" instead of "Chilakaluripet Vijayawada" and the same may be corrected.

4. The information noted against item no. 1.14 of the checklist shall be reviewed and corrected.

In this connection, PIU vide letter no. NHAI/PIU-Amaravati/11013/13(OFC)/2020/Vol.1/10 dated 04.01.2022 communicated the above observation to the applicant M/s. Jio Digital Fibre Private Limited and requested to submit compliance for the same.

Accordingly, applicant M/s. Jio Digital Fibre Private Limited submitted compliance to the above observations vide letter no. nil dated 28.01.2022 received in this office on 22.02.2022and requested permission for laying Optical Fiber Cable(OFC).

The compliance submitted by the applicant was got examined through IE, M/s.MSV International Inc in association with Sri Infotech and IE vide letter no. MSV_Sri Infotech/103/KAZA/2021/NHAI/0347 dated 07.03.2022 submitted as follows:

- 1. The applicant has submitted:
 - (i). Checklist
 - (ii). Undertaking for submission of Performance Bank Guarantee @ Rs.100/- per route meter.
 - (iii). Undertaking for Shifting / Relocation of O.F. Cable (as per Sl.No.5 of Check list)
 - (iv). Undertaking for no damages in carrying out works
 - (v). Draft license agreement regarding granting of ROW permission for laying telecom cable / O.F. Cable / ducts.
 - (vi). Indemnity Bond.
 - (vii). License Fee estimate for laying optical Fiber cable on NH-16 with supporting
- 2. As per the plan submitted, the applicant has proposed to lay the Optical Fibre Cable parallel to the road by Open Trench Method. The trench will be in the ROW within 2m utility corridor and will be straight along the highway. At road crossings, restricted ROW, Drains, Culverts, Bridges the applicant has proposed Horizontal Direction Drilling Method (HDD Method).
- 3. Applicant has submitted the typical cross sections of Optical Fibre Cable trench and typical cross-section for HDD with methodology.

While submitting the above IE recommended the proposal, requesting for approval of Competent Authority for laying OF cable as requested by the applicant.


