It is to inform all concern that M/s Vodafone Idea Telecom Infrastructure Ltd. vide letter under reference (ii) has submitted a proposal for the subjected work and PD, NHAI, PIU-2, Nagpur has recommended the above proposal vide letter under reference (i) for approval of the Competent Authority / Highway Administrator.

2. The alignment proposed by that M/s Vodafone Idea Telecom Infrastructure Ltd. along on Nagpur-Saoner-Betul Section of NH-47 in the State of Maharashtra is as follows:

Underground Optical Fiber Cable to be laid in duct in utility corridor from km. 40+150 to km 42+250 on RHS section of Nagpur – Saoner – Betul of NH-47 at the edge of RoW.

- 3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
