Sub: Improvement, operation and maintenance including strengthening and widening of existing 2-lane road to 4-lane dual carriageway from Km.9.200 to Km.50.000 of NH-6 (Nagpur- Kondhali section) in the State of Maharashtra on Build, Operate and Transfer (BOT) basis-Proposal for grant of permission to lay off 18" dia Natural Gas Pipeline alongwith 40mm OFC cross National Highway 53 at km 20.500, village Gondkhairi Taluka Kalmeshwar, Dist. Nagpur on Nagpur - Kondhali section NH-53 in the State of Maharashtra-Reg.

It is to inform all concern that M/s GAIL (India) Limited vide letter under reference (ii) has submitted a proposal for the subjected work and PD, NHAI, PIU Amravati, has recommended the above proposal vide letter under reference (i) for approval of the Competent Authority / Highway Administrator.

2. The alignment proposed by M/s GAIL is for crossing of 18" dia Natural Gas Pipeline alongwith 40mm OFC cross National Highway 53 at km 20.500, village Gondkhairi Taluka Kalmeshwar, Dist. Nagpur on Nagpur - Kondhali section NH-53. The following work is included:

Crossing of Gas pipeline 18" dia at km 20.500 on National Highway No. 53 through HDD Method.

3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).

In view of the above, the comments / objections of affected public is hereby invited with reference to the Ministry's circular dated 22.11.2016 due to above underground line on the subjected stretch.
