2. The alignment proposed by that M/s Shri Bhagirathi Textiles Ltd. is along Nagpur -

Karol Section of NH-353J in the State of Maharashtra is as follows:

Laying of 33 KV Cable km from Ch. 24.100 to km Ch. 31.640 (total length 7.540 km) on NH-353J at edge of ROW

Crossing by HDD method of HT cable across at Ch. 31.640 near SBTL for 33kV HT supply form 220KV Kalmeshwar S/Stn to Shri Bhagirathi Textile Pvt. Ltd.
