**Sub:** NHAI, PIU, Coimbatore - Strengthening and Widening the existing 2 lane carriageway to 2 lane with paved shoulders from Km 0+000 to Km 85+000 of NH-544H (NH(O) Project (Thoppur -Mettur -Bhavani -Erode section) for a length of 85 Km - **Request for permission to lay underground Optical Fibre Cable [OFC] on NH-544H [Thoppur-Mettur Dam- Bhavani-Erode Road] between Km:21/053 to Km:22/560[LHS] and across @ Km:21/053 of NH-544H in the limits of National Highways Authority of India, Coimbatore - reg.**

1. The proposal is regarding permission for laying Optical Fibre Cable in NH-544H Road (Thoppur-Mettur Dam- Bhavani-Erode Road) along the road from Km.21+053 to Km.22+560 (LHS) across at Km:21/053.
