**INVITATION OF PUBLIC COMMENTS**

Sub:- NHAI-RO Kerala- Construction of new 4 lane Elevated Highway (2x10.50m) wide twin two Lane structures) including approaches and service roads connecting Kazhakuttom Junction & Technopark of NH-47 (New NH-66) from KM 547.080 to KM 549.801 in the State of Kerala on EPC mode-Laying of 400 KV, 3x300 sqmm XLPE UG cable for giving HT/LT power to M/s Atomic Building near Techno Park, Kazhakuttam from Km.549+237 to Km.549+252-Reg.

The proposal is regarding permission sought by M/s Atomic Building, Kazhakuttam, for laying of 400 KV, 3x300 sqmm XLPE UG cable from Km. 549+237 to Km.549+252 on NH-66 in Thiruvananthapuram Bypass in the subject project stretch in the State of Kerala.

2. M/s Atomic Building, Kazhakuttam has furnished undertaking to shift the XLPE UG cable at their own cost at an alternate location whenever NHAI or any other road authorities make a request for shifting of the same. Further, the applicant has undertaken for payment of rent/fee and to confirm with all standards as mentioned in the Ministry's Circular No. RW/NH-33044/29/2015-S&R dated 22.11.2016.

3. Further, M/s Atomic Building, Kazhakuttam has undertaken that they will not damage any other utility during the process on laying and in case, if damaged, then to pay the losses either to NHAI or to the agency concerned. Further, M/s Atomic Building, Kazhakuttam has also undertaken to manage traffic movement during the execution of the work.

4. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by M/s Atomic Building, Kazhakuttam will be made available for 30 days seeking public Comments/objections and the comments shall be furnished within 30 days from the day of closure of public objections.
