INVITATION OF PUBLIC COMMENTS

Sub:- NHAI-RO Kerala- Four Lane NH Connectivity of Edappally-Vyttila-Aroor section of NH -66 from Km.342.000 to Km.358.750 in the state of Kerala-Proposal for improving water supply to Cheranellore Panchayath - Supplying and laying 450mm D1-K9 pipe from Thammanam Pump House to Vadathodu Tank site (Km.342+000 to Km.346+900)(Length of 4.9 Km) through Service Roads-Reg.

1. The proposal is regarding permission sought by Kerala Water Authority for laying of 450mm D1-K9 pipe from Thammanam Pump House to Vadathodu Tank site (Km.342+000 to Km.346+900)(Length of 4.9 Km) through Service Roads by virtue of providing concrete duct of 1.6 m along the subject project stretch in the State of Kerala.
2. Kerala Water Authority has furnished undertaking to shift the underground pipeline at their own cost at an alternate location whenever NHAI make a request for shifting of the same. Further, the applicant has undertaken for confirming with all standards as mentioned in the Ministry's Circular.
3. Further, Kerala Water Authority has undertaken that they will not damage any other utility during the process on laying and in case, if damaged, then to pay the losses either to NHAI or to the agency concerned. Further, Kerala Water Authority has undertaken to bear the expenditure incurred by NHAI for repairing any damages caused to the NH by laying, maintenance or shifting of the proposed water supply line.
4. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by Kerala Water Authority will be made available for 30 days seeking public Comments/objections and the comments shall be furnished within 30 days from the day of closure of public objections.
