



- 3. Accordingly, M/s Telesonic Networks Limited vide ref. 7th cited has submitted the Performance Bank Guarantee & License fee. The work to be executed by HDD method only and payment received for HDD method only and pits have also being considered.
- 4. Further, this office letter vide ref. 8th cited has addressed to Canara Bank, Hyderabad requested to confirm the Performance Security as submitted by the Telesonic Networks Limited.
- 5. The applicant has submitted an Undertaking vide ref. 9th cited requesting to permit them to take up the work for laying of the Optical Fiber Cable along NH-44 from Km.23.680 to Km.24.550 (LHS) and Km.29.700 to Km.30.140 (LHS) & Km.31.550 to Km.32.250 (LHS) & across the road between Km.24.500 & Km.31.100-200, Km.31.500 & Km.39.200-300 for a total length of 2250m and if any objections are received regarding laying of optical fiber cable within the mandatory 30-day period, they would immediately stop all activities in the subject stretch and undertake to remove the optical fiber cable.
- 6. In view of the above, the proposal is recommended for 'in-principle' approval for subject cited permission of M/s Telesonic Networks Limited.
