INVITATION OF PUBLIC COMMENTS

Sub: NHA, Madurai Region - Highway Administration - Operation and Maintenance of Madurai - Aruppukottai section from Km.138.800 to Km.266.865 of NH-45B in the State of Tamil Nadu - Erection of 33 KV Overhead Electrical Line along the road from Km.150+220 to Km.151+060 RHS by M/sEnerjay Green Pvt Ltd.

The proposal is regarding permission for Erection of 33 KV overhead electrical line along the road from NH from Km.150+220 to Km.151+060 RHS in Madurai - Aruppukottai section of NH-45B in the state of Tamil Nadu in accordance with Ministry's latest guideline dated 22.11.2016.

2. The alignment proposed by the Enerjay Green Pvt Ltd, Rajapalayamfor Erection of 33 KV overhead electrical line along the road NH fromKm.150+220 to Km.151+060 RHS in Madurai - Aruppukottai of NH-45 in the State of Tamil Nadu as detailed under:

3. The Right of Way is 60 m in the aforesaid stretch. The proposed Erection of 33 KV overhead electrical line along the road NH fromKm.150+220 to Km.151+060 in Madurai - Aruppukottai section of NH-45B. Further, the Enerjay Green Pvt Ltd, Rajapalayamhas given undertaking that the vertical clearance 12 from the Natural Ground level of the road which is in conformity with Ministry's latest guidelines dated 22.11.2016.

4. The applicant has furnished an undertaking that they will shift the erected electrical line in future when required by NH Authority at any time for expansion of the NH at their own cost without claiming any compensation from NHA. Also, certified that, the proposed erection of 33 KV overhead electrical line work will not affect the design, stability, traffic safety and future improvement of the proposed stretch.

5. As per the guidelines issued by the Ministry vide letter No. RW/NH-33044/29 /2015/S&R(R) dated 22.11.2016, the application submitted by the applicant will be made

available for public comments and the comments will be invited within 30 days from the day of uploading.
