Invitation of Public Comments

Sub: NHAI, PIU – Puducherry – N/09048/01001/TN – Proposal for laying of underground Sewerage Pipeline on NH-66 along the road from Km.37/150 to Km.37/550 (RHS), Km.37+700 to Km.38/600 (LHS) and Km.37/750 to Km.37/600 (RHS) with Manhole(2mx2m) @30m Spacing and also a crossing at Km.37/750 & Km.38/450 of NH66, for a total length of 2.15Km along the NH and Two crossing across NH by TWAD Board– Invitation for Public Comments – reg.

- 1) The subject proposal is requesting a permission to lay an underground Sewerage Pipeline along the NH-66 by open excavation- c.f 200mm Dia CI pipe from from Km.37/150 to Km.37/550 (RHS), Km.37+700 to Km.38/600 (LHS) and Km.37/750 to Km.37/600 (RHS) with Manhole(2mx2m) @30m Spacing and 400mm dia MS encasing pipe by HDD method across NH at Km.37/750 & Km.38/450 in the project stretch of Pondicherry to Tindivanam section of NH-66.
- 2) TWAD Board, RWS Division, Villupuram had given an undertaking to shift the utility line for any work of improvement or repairs to the road, If NHAI considers it as necessary, in the future, it will be carried out as desired by the NHAI at the cost of the applicant within a reasonable time (not exceeding 60 days) of the intimation given. Further, the applicant has furnished the undertaking to pay rent/fee as mentioned in the Ministry's Circular No. RW/NH-33044/29/2015-S&R Dt.22.11.2016 as and when asked by NHAI.
- 3) As per the guidelines issued by the Ministry vide letter No. RW/NH-33044/29/2015/S&R(R) Dt.22.11.2016, the proposal submitted by TWAD Board, RWS Division, Villupuram will be put out in the Ministry's website for 30 days seeking Claims/Comments/ Objections (on ground of public inconvenience, safety, and general public interest) from the day of disclosure in the website.
