As part of this project, we must laying underground optical Fiber Cable (OFC) through HDPE ducts across NH65-KM 21/500,23/200 and 24/600 for a total route length of crossing 180 meters (Across the road each 60 meters) in Vuyyuru Mandal, Krishna District of Andhra Pradesh the Jurisdiction of NHAI, PIU, Vijaywada.

The HDPE ducts of 40mm dia (50mm OD) x 2 ducts will be laid at the extreme possible edge of RoW at a depth of 1.65 mtrs., using various methods like Open Trenching, Horizontal Directional Drilling (HDD), Clamping and other suitable method as required on the ground to construct a Fiber Optic backbone link.


