It is to inform all concern that M/s Maharashtra State Electricity Distribution Company Ltd. letter under reference (2) has submitted a proposal for the subjected work and PD, NHAI, PIU, Aurangabad has recommended the above proposal vide letter under reference (1) for approval of the Competent Authority / Highway Administrator.

- 2. The alignment proposed by M/s Maharashtra Industrial Development Corporation, Aurangabad is along Aurangabad-Paithan Section of NH-752-E in the State of Maharashtra as follows:
 - Laying of (700mm dia. DI K-9 Pipe) pipeline along Highway from Ch. 2.500 to Ch. 3.700 at the extreme edge of RoW using open trench method at 2m below ground level.
 - Crossing at km 2.500 through HDD method.
- 3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
