Sub: NHAI-PIU-NSK-Widening of existing 2 lane carriage way to 4/6 lane carriageway configuration for Dhule - Pimpalgaon (Km 265.00 to Km 380.00) section of NH-3 in the State of Maharashtra- Dhule Municipal Corporation, Dhule's Proposal for Laying of Water Supply Pipeline from Km. 264.490 to Km. 265.010 on RHS (Length 520m) along NH-3 in the State of Maharashtra.

Commissioner & Administrator, Dhule Municipal Corporation, Dhule vide letter cited above has submitted proposal for Laying / Crossing Water Supply Pipeline along / across NH-3 for approval of the Competent Authority, Highway Administration.

2. From the submitted proposal, it is observed that, the Laying of Water Supply Pipeline along NH-3 (Dhule-Pimpalgaon Section) is proposed from Km. 264.490 to Km. 265.010 on RHS (Length 520m) along NH-3.

3. As per Para-4 of Ministry Circular No. RW/NH-33044/29/2015/S&R(R), Dtd. 22.11.2016, the Highway Administration shall put out in the Public Domain for 30 days for seeking claims and objections (On grounds of Public inconvenience, safety and general public interest).
