SUB: Project comprising of 9 National Highway stretches (Bundle-1) on Toll, Operate, Transfer Mode - Porbandar - Jetpur section (from Km. 0.000 to 117.600) of NH 8B in the state of Gujarat - **Permission of laying and crossing proposed 700mm dia MS potable drinking water pipeline within NH ROW along NH-27 (Porbandar to Jetpur) for providing basis utility service, across crossing at Ch. 7+940 km - Reg.**

The Project Director, PIU-Rajkot vide u/ref.
