Invitation of Public Comments

Sub: NHAI, PIU – Viluppuram – Proposal for laying of underground Optical Fiber Cable (OFC) on NH-45 along the road from Km.178/600 to Km.178/650 (RHS), Km.181/000 to Km.181/600 (RHS) & Km.191/300 to Km.191/450 (RHS) and also crossing at Km.178/600 (RHS-LHS), Km.181/000 (RHS-LHS) and Km.191/450 (RHS-LHS) for a total length of 800m along NH and 3 Nos. of crossing across NH by M/s. Vindhya Telelinks Limited, Telegana – Approval Requested – reg.

- 1) The subject proposal is requesting permission for laying of underground Optical Fiber Cable (OFC) along the NH-45 by open excavation of 40mm Dia PLB pipe from Km.178/600 to Km.178/650 [RHS], Km.181/000 to Km.181/600 [RHS] & Km.191/300 to Km.191/450 [RHS] and 150mm dia RCC casing pipe by HDD method across NH at Km.178/600, Km.181/000 and Km.191/450 in the project of Tindivanam to Ulundurpet section of NH-45.
- 2) M/s. Vindhya Telelinks Limited, Telegana has furnished an undertaking to move the utility line for any work of improvement or repairs to the road, If NHAI considers if necessary, in future, it will be carried out as desired by the NHAI at their cost within a reasonable time (not exceeding 60 days) of the intimation given. Further, the applicant has furnished the undertaking for payment of rent / fee as mentioned in the Ministry's Circular No. RW/NH-33044/29/2015-S&R Dt.22.11.2016 as when asked by NHAI.
- 3) As per the guidelines issued by the Ministry vide letter No. RW/NH-33044/29/2015/S&R(R) Dt.22.11.2016, the proposal submitted by M/s. Vindhya Telelinks Limited, Telegana will be made available for 30 days seeking comments/objection and shall be furnished within 30 days from the day of closure of public objections.
