Sub: 4-laning of NH-7 from MP/MH Border to Nagpur i.e. from Km. 652 to Km. 729 of NH-7 including Construction of Kamptee - Kanhan & Nagpur bypass and including maintenance of already 4 laned section of NH-7 from km 14.585 to Km 36.600 (Nagpur Hyderabad section) on DBFOT basis - **Permission for laning of underground Pipeline approx. 10 km in length, out of 10 km approx.. 2.5 km Kamptee (Ch. 719+850) to the factor situated at village Dhargaon, Tehsil Kmaptee Dist. Nagpur (Ch. 722+350) & crossing the Road from underground pipeline by push through method at village Lihigaon under flyover (Ch. 720+200) - Reg.**

It is to inform all concern that M/s Harrishiv Healthy Foods & More Pvt. Ltd. vide letter under reference (ii) has submitted a proposal for the subjected work and PD, NHAI, PIU-1, Nagpur has recommended the above proposal vide letter under reference (i) for approval of the Competent Authority / Highway Administrator.

2. The alignment proposed by that M/s Harrishiv Healthy Foods & More Pvt. Ltd. along on MP/MH Border to Nagpur i.e. from Km. 652 to Km. 729 of NH-7 including Construction of Kamptee - Kanhan & Nagpur bypass and including maintenance of already 4 laned section of NH-7 from km 14.585 to Km 36.600 (Nagpur Hyderabad section) at Ch. 719+850 to Ch. 722+350 and crossing at Ch. 720+200 on NH-44 in the State of Maharashtra is as follows:

- Underground Water Supply pipeline laying from Design km. Ch. 719+850 to Ch. 722+350 in utility corridor & crossing 01 nos. at Ch. 720+200 in Nagpur to Hyderabad section of NH-44.
- Laying water line at edge of ROW, in utility corridor from Design Ch. 719+850 to Ch. 722+350 in trench and Crossing at Ch. 720+200 to be carried out by HDD/Push Through Method.
- Water line to be laid 1.2m below ground level in both method.

3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).

4. In view of the above, the comments / objections of affected public is hereby invited with reference to the Ministry's circular dated 22.11.2016 due to above underground line on the subjected stretch. The objections / comments may be addressed to the below mentioned address upto 18.09.2021, beyond due date, no comments/ objections will be accepted.
