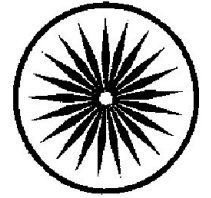

(i)	In submitted checklist Sl.No. 2.4.1(a) the maximum trench width mentioned as 120cm wider whereas as per the MoRT&H Circular dated 22.11.2016, the maximum trench width across the national highway shall not be more than 60cm wider.	In crossing application against point No. 2.4.1 (a) of checklist, it is submitted that the trench width would be at least 30 cm wide but not exceed 60cm to outed dia of pipes
(ii)	The applicant has not submitted the requisite safety clearances from CPCB/Petroleum NGRB/Oil Industry.	Copy Attached
