Sub: Proposal of permission for laying of Optical Fiber Cable of M/s. Telesonic Network Limited along and across NH-52 from Km.338.400 to Km.370.200 (Length 31.800 Km.) and 10 nos. of crossings on Karodi - Telwadi Section of NH-52 in the State of Maharashtra - Reg.

It is to inform all concern that the M/s. Telesonic Network Limited, Mumbai vide letter under reference (ii) has submitted a proposal for the subjected work and PD, NHAI, PIU, Aurangabad has recommended the above proposal vide letter under reference (i) for approval of the Competent Authority / Highway Administrator.

2. The alignment proposed by that the M/s. Telesonic Network Limited, Mumbai along and across NH-52 from Km.338.400 to Km.370.200 (Length 31.800 Km.) and 10 nos. of crossings on Karodi - Telwadi Section of NH-52 in the State of Maharashtra is as follows:
 - From Km.338.400 to Km.370.200 i.e. from MS Virul Manhole to MS Kannad
 - Crossing at Km.338.400, Km.347.500, Km.356.100, Km.356.200, Km.357.500, Km.368.600, Km.368.900, Km.369.400, Km.369.500 and Km.370.200
 - Laying of above utility is in utility corridor i.e. 28-30m from the centre line
3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
4. In view of the above, the comments / objections of affected public is hereby invited with reference to the Ministry's circular dated 22.11.2016 due to laying of 220 KV D/C Karodi-II - Uppalwadi underground cable on the subjected stretch. The objections / comments may be addressed to the below mentioned address upto 06.01.2021, beyond due date, no comments/ objections will be accepted.
