Sub: Widening of existing 2 lane road to 4/6 lane dual carriageway from Talegaon - Amravati section (including Amravati bypass) of NH-6 in km 100.000 to km 166.725 in the State of Maharashtra -Proposal for laying of Water Supply Pipeline from km. 161.200 to km 162.600 (LHS) for total length of 1200 Mtr and crossing at 162.350 in the State of Maharashtra - Reg.

It is to inform all concern that Executive Engineer, MJP W.M. Div. Amravati vide letter under reference (ii) has submitted a proposal for the subjected work and PD, has recommended the above proposal vide letter under reference (i) for approval of the Competent Authority / Highway Administrator.

- 2. The alignment proposed by that MJP W.M. Division, Amravati along on Talegaon Amravati Section of NH-53 (Old NH-06) in the State of Maharashtra is as follows:
  - Laying of (150mm dia. DI K-7 M.S. Pipe) pipeline along Highway from Ch. Km 161.200 to Ch. km 162.350 on LHS at the extreme edge of RoW using open trench method at 1.2m below ground level.
  - Crossing at Ch. 162.350 through HDD method.
- 3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
- 4. In view of the above, the comments / objections of affected public is hereby invited with reference to the Ministry's circular dated 22.11.2016 due to above underground line on the subjected stretch. The objections / comments may be addressed to the below mentioned address within 30 days from issuance of public comments, beyond due date, no comments/ objections will be accepted.
