This has reference to the letter under reference above, thereby recommending the proposal for obtaining access permission to the newly proposed Retail Outlet of M/s HPCL, for installation of New Petrol pump at Km 134.207 RHS at Village Tongseng, PS Khliehriat, PO Khliehriat, District: East Jaintia Hills, Megahalaya and requested for accord of final NOC for the same.
