SUB: Four laning of Gujarat/Maharashtra Border - Surat-Hazira Port Section of NH-6 (approx. length 131.500 km) in the State of Gujarat under NHDP Phase III.

- Proposal seeking ROW Permission for laying and Crossing of proposed UG 125mm Ø PE & 4" Ø Steel Gas Pipeline along National Highway-53 from (i) Km 30+500 to Km 30+729 (LHS) (Hazira-Palsana), (ii) from Km 30+500 to Km 31+079 (RHS) (Hazira-Palsana) & (iii) across NH-53 at Km 30+500, Village-Budiya, Taluka-Surat, District-Surat GA in the state of Gujarat.


