2. The Right of Way in the stretch of NH proposed for laying Electrical Cable line is 22.80m. The carriageway width of stretch at Km. 10/300 of NH-381 is 17.30m. The Executive Engineer, Transmission line Construction, TANTRANSCO, Perundurai has proposed to laying 110KV, 1Cx630 sq.mm (3 Runs) underground Electrical Cable Line across road by adopting trenchless method at a depth of 2.30m from the bottom of the road.

3. The Executive Engineer, Transmission line Construction, TANTRANSCO, Perundurai has furnished an undertaking to the effect that they will remove the laid Public Utility Electric cable line in future if required by NH Authorities/MoRTH, Government of India at any time for expansion of the NH at their own cost without claiming any compensation from NH Authorities/MoRTH, Government of India and any right on the NH land. Further, mentioned that, the Executive Engineer, Transmission line Construction, TANTRANSCO, Perundurai will also restore the ROW surfaces to its original condition soon after removal of the Public utility Electric cable lines. Also, certified that the proposed Public Utility work will not affect the design, stability, traffic safety and future improvement of the proposed stretch.
