Sub: NHAI, PIU, Coimbatore - Short Term Maintenance of Pollachi to Coimbatore Section (Km 123.550 to Km. 150.400 of NH 209 (New NH 83) in the State of Tamil Nadu - *Permission for laying of a Public Utility Liquefied petroleum gas pipeline (LPG) 12.75" Carbon Steel pipeline with OFC cable in HDPE duct (50mm) across the NH-83 (Old No. 209 at Ch: 147/232KM) road at Malumichampatti junction at Madukkarai taluk in Coimbatore district - reg.*

1. The proposal is regarding permission for Laying of petroleum gas pipeline (LPG) along with OFC duct in NH-83(Old NH 209) Road (Pollachi to Coimbatore Section) Crossing @ Km 147+232 at Malumichampatti junction by HDD method.
