Sub: NHAI - PIU Coimbatore - Laying of Water Pipe line in NH-544H Road (Thoppur - Bhavani Section) along the road from km 0/000 to km 17/810 (RHS), km 26/180 to km 27/180 (LHS). Km 29/338 to km 30/055 (LHS), km 33/545 to km 33/820 (LHS), km 34/050 to km 36/250 (LHS) & km 36/250 to km 37/050 (RHS) and Crossing @ km 10/380, km 15/395, km 17/810 km 27/180, km 36/250 & 37/050 by open trench & HDD method by Tamilnadu Water Supply And Drainage Board, Salem.

- 1. The proposal is regarding permission for laying water pipeline on the above said project chainages by open trench & HDD method for a length of 22802 m along the road and Six crossings at the chainages mentioned above by Tamilnadu Water Supply and Drainage Board, Salem.
- 2. Tamil Nadu Water Supply and Drainage Board, Salem has furnished an undertaking to accept any claims raised by the Authority, if any and the same will be paid by them and also furnished undertaking not to damage other utility, if damaged, then to pay the losses either to NHAI or to the concerned agency.
