- Sub: NHAI, PIU, Coimbatore Strengthening and Widening the existing 2 lane carriageway to 2 lane with paved shoulders from Km 0+000 to Km 85+000 of NH-544H (NH(O) Project (Thoppur -Mettur -Bhavani -Erode section) for a length of 85 Km - Request for permission to lay underground Optical Fiber Cable (OFC) on NH 544H Thoppur Bhavani Section) Along the road from Km 12+400 to Km 12+900 (LHS), Km 25+950 to Km 26+200 (RHS) and crossing at Km 12+400, Km 12+900, Km25+950 and Km 26+200 in the state of Tamil Nadu - reg.
- 1. The proposal is regarding permission for laying Optical Fibre Cable by M/s. JIO Digital Fibre Pvt. Ltd. in NH-544H Road (Thoppur-Mettur Bhavani Erode Road) along the road from Km 12+400 to Km 12+900 (LHS), Km 25+950 to Km 26+200 (RHS) and crossing at Km 12+400, Km 12+900, Km25+950 and Km 26+200.
