The Project Director, PIU - Amaravati submitted a proposal of M/s. APCPDCL for laying of Utility Services on National Highways for Over Head Electrical Line (33KV) from Km.433+550 to Km.433+700 (RHS) & Over Head Crossings Km.433+700 & Km.432+000 [(Total Length = 350M (150M + 100M+100M)] of NH-16 on Chilakaluripet - Vijayawada section at Tadepalli, Kunchanapalli & Kolanukonda Villages of Tadepalli Mandal, Guntur District in the State of Andhra Pradesh.

As per MORTH guidelines vide letter No. RW/NH-33044/29/2015/S&R(R) dated 22nd November 2016, the Highway Administration will put out the application in the Ministry's website for 30 days seeking claims and objections (on grounds of public inconvenience, safety and general public interest).

It is to inform that Andhra Pradesh Central Power Distribution Corporation Limited, vide reference 1st cited requested permission for laying Utility Services on National Highways for Over Head Electrical Line (33KV) from Km.433+550 to Km. 433+700 RHS & Over Head Crossings @Km.433+700 & Km.432+000 [(Total Length = 350M(150M + 100M+100M)] of NH-16 (Old NH-5) on Chilakaluripet - Vijayawada section at Tadepalli, Kunchanapalli & Kolanukonda Villages of Tadepalli Mandal, Guntur District in the state of Andhra Pradesh.

2. In this connection, PIU vide reference 2nd cited forwarded the proposal to IE, M/s MSV Intl. Inc. in association with M/s Sri Infotech, with a request to examine the proposal as per MoRTH guidelines and to furnish necessary comments/ recommendations.

3. Accordingly, IE, MSV Intl. Inc. In association with M/s Sri Infotech vide reference 3rd cited submitted as follows:

H.Q.: G-5 & 6, Sector - 10, Dwaraka, New Delhi - 110 075,

R.O.: "Raj Maarg Bhavan", # 41-29-45A, Kodanda Ramalayam, Chalasani Nagar, Ranigari Thota, Krishnalanka, VIJAYAWADA, A.P. -520 013.

- 1. The width of the ROW at the location proposed for laying utility services is 50.00m on LHS and 50.00m on RHS from centreline.
- II. As per the plan submitted, the applicant has proposed 33KV Over Head Electrical line from Km. 433+550 to Km. 433+700 RHS along the Highway with spun poles & M+9 Towers & Over Head Crossings at Km. 433+700 & Km. 432+000 [Total Length = 350m (150m + 100m + 100m)] with M+9 Towers.
- III. The applicant has submitted Checklist, Drawings and other relevant documents as per NHAI guidelines.
- IV. The proposed site was checked with the checklist, drawings and other documents submitted by the applicant and all the items in the checklist are satisfying the guide lines of MoRTH circular F.No. RW-NH-33044/29/2015-S&R(R) dated 22.11.2016 & NH-36094/01/2022-S&R(P&B) (E-208825) dated 24.04.2023.
- V. The applicant has submitted all relevant undertakings such as:
- a. To furnish Performance Bank Guarantee calculated at the rate as per Ministry Circular per route Meter to NHAI for a period of one year initially.
- b. To furnish a fresh Bank Guarantee or extend the Bank Guarantee for a period of one year, in case the work contemplated is not completed to the satisfaction of Authority, which has granted the permission within a period of 11 months from the date of issue of Bank Guarantee.
- c. To Pay Licensee Fees/Lease Rental charges for granting License for use of Highway Land whenever charged by the Highway Administration as per point no. 5 of MoRTH guidelines dated 22.11.2016.
- d. Not to damage to other utility, if damaged then to pay the losses either to NHAI or to the concerned agency.
- e. To confirm all standard conditions of Ministry Circulars and NHAI Guidelines.
- f. Indemnify NHAI against all damages and claims.
- g. To Manage Traffic movement during laying of Utility line without hampering the traffic.
- h. If any claim is raised by the Concessionaire/Contractor then the same will be paid by applicant.
- i. Prior approval of the NHAI shall be obtained before undertaking of any work of installation, shifting or repairs or alterations of the Utility located in the National Highway right of way.
- j. To bear expenditure, if any, incurred by NHAI for repairing any damage caused to the National Highway by the laying maintenance of shifting of the Utility line.

- k. Text of the license deed is as per verbatim of MoRTH format (issued vide Ministry's Circular no. RW/NH-33044/29/2015/S&R (R) dated 22.11.2016).
- l. To shall utility as and when asked by MoRTH/NHAI.
- m. To manage traffic movement during laying of 33KV Electrical line.
- n. If NHAI considers in necessary in future to move the utility line for any work of improvement or repairs to the road, it will be carried out as desired b NHAI at the cost of the agency owning the utility line within a reasonable time (not exceeding 60 days) of the intimation given.
- VI. Applicant has submitted Certificates such as,
 - a. Laying of utility (Electrical Line) will not have any deleterious effects on any of the bridge components and roadway safety for traffic.
 - b. This proposal implemented now will not affect any likely future improvement to geometries.
 - c. The Proposal is in accordance with the Government of India specifications.
 - d. We do undertake that, we will relocate the utility line at our own cost notwithstanding the permission granted within such time as will be stipulated by NHAI for future six-laning or any other development.
 - e. We undertake that permission does not lead to the adverse impact on the safety and stability of the highway structures.
- VII. The applicant has submitted detailed drawings and methodology for erecting 33KV Overhead Electrical line.

4. While submitting the above, IE recommended the proposal of Andhra Pradesh Central Power Distribution Corporation Limited for laying of Over Head Electrical line (33KV) for approval of Competent Authority as requested by the applicant.

5. Further, it is to submit that the location falls under Chilakaluripet-Vijayawada section of NH-16 and the BoT(Toll) Concession period was completed on 21.07.2024. Hence, objections of the Concessionaire are not required.

6. The applicant has submitted calculation of license fee and Performance Bank Guarantee for Rs. 56,371/- and Rs.35,739/- respectively and the same have been verified as per MoRTH guidelines and found in order.

7. The proposal of laying of Over Head Electrical line (33KV) has been examined along with the comments of IE and found to be in line with guidelines issued vide MoRTH Circular dated 22.11.2016.

In light of the above, the proposal along with the copies of all the above mentioned documents are herewith submitted with a request to communicate the approval of the Competent Authority for laying Utility Services on National Highways for Over Head Electrical Line (33KV) from Km.433+550 to Km. 433+700 RHS & Over Head Crossings @Km.433+700 & Km.432+000 [(Total Length = 350M(150M + 100M+100M)] of NH-16 (Old NH-5) on Chilakaluripet - Vijayawada section at Tadepalli, Kunchanapalli & Kolanukonda Villages of Tadepalli Mandal, Guntur District in the state of Andhra Pradesh, at an early date
