
- 1). The subject proposal is requesting permission for laying proposed 16" dia Multi Product pipeline along the road from Km 32/800 to Km 34/720 (LHS) & across at Km 34/720 (Salem to Kumarapalayam section on NH-544) for a total length of 1920 meters by Open Trench & HDD Method in the project of Salem to Kumarapalayam section of NH-544 in the State of Tamil Nadu.
- 2). M/s Bharat Petroleum Corporation Ltd, Coimbatore has furnished an undertaking to move the utility line for any work of improvement or repairs to the road, if NHAI considers if necessary in future, it will be carried out as desired by the NHAI at their cost within a reasonable time (not exceeding 90 days) of the intimation given. Further, the applicant has furnished the undertaking for payment of rent / fee as mentioned in the Ministry's Circular No.RW/NH-33044/29/2015-S&R dated 22.11.2016 as when asked by NHAI.
- 3). As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by M/s.Bharat Petroleum Corporation Ltd, Coimbatore will be made available for

30 days seeking public comments / objection and shall be furnished within 30 days from the day of closure of public objections.
