Invitation of Public Comments Sub: 4-Laning of Medshi to Washim (Package II) from Km 47.700 to Km 92.200 (Design Chainage) Section of NH-161 including Bypasses at Malegaon and Washim in the State of Maharashtra on EPC mode - Proposal for laying Water supply pipeline for plantation work of NMSCEW from Ch. 47.440 to Ch. 51.000 (3.56 km length) along NH-161-Reg.

It is to inform all concern that M/s MSRDC, letter under reference (2) has submitted a proposal for the subjected work and PD, PIU Washim has recommended the above proposal vide letter under reference (1) for approval of the Competent Authority / Highway Administrator.

2. The alignment proposed by that M/s MSRDC is laying Akola-Medshi section of NH-161 in the State of Maharashtra is as follows:

• Laying Water supply pipeline for plantation work of NMSCEW from Ch. 47.440 to Ch. 51.000 (3.56 km length) (Open Trenching Method).

3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
